

POTENTIAL RECIPIENTS

At times it may be necessary for other persons to receive your personal data. For instance, this may be required by law or necessary for the performance of a mandate. Here is an overview of the potential recipients of your data.

Please bear in mind:

- an entry in this list does not necessarily mean that the data will be sent to all recipients in your case.
- not every recipient will necessarily receive all the personal data we have.

1. Processors

We need to call in processors, including sub-processors, to enable us to provide our Services. Processors are legally and contractually bound to process your personal data only for our purposes and on the basis of our instructions (Article 28 GDPR).

In this sense, they act as the "extended arm" of the bank. Processors may be located in the European Economic Area (EEA) or outside it, in a so-called "third country". If a processor is located in a third country, we will state the legal basis on which the transfer is based separately. In any case, however, the following applies: all customer data are securely stored in a data centre in Austria.
